#### BOOTS ON THE BEACH FLYAWAY CONTEST RULES

THE BOOTS ON THE BEACH FLYAWAY CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCES OF ALBERTA AND ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THEIR PROVINCE OF RESIDENCE OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

#### 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Alberta or Ontario;
  - (b) be of the age of majority in their province of residence or older at the time of entry; and
  - (c) be legally able to travel to Riviera Maya, Mexico (the "**Destination**") between January 21, 2024 and January 30, 2024 and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.
- 1.2 The following people are not eligible to enter the Contest:
  - (a) Employees of Corus Radio Inc., operating as CKDK-FM, CISN-FM, CKRY-FM (each a "Station", collectively the "Stations") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Stations, "Corus");
  - (b) Employees of Vision Travel DT Ontario West Inc., dba Direct Travel, its affiliates, subsidiaries, related companies, successors and assigns (collectively, "**Direct Travel**", together with Corus, the "**Sponsors**");
  - (c) Employees of Washboard Union Productions Inc., its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies (collectively "Washboard Union");
  - (d) Any person who has been confirmed as a winner of any Station administered contest within sixty (60) days preceding the Contest start date indicated below where the prize was valued over five hundred Canadian dollars (CDN\$500.00); and
  - (e) The household members of any of the parties listed in Section (a) to (d) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. For Ontario residents, the Contest begins at 12:00 a.m. Eastern Time ("ET") on November 27, 2023 and ends at 3:59 p.m. ET on December 15, 2023 (the "ON Contest Period") and for Alberta residents, the Contest begins at 12:00 a.m. Mountain Time ("MT") on November 27, 2023 and ends at 3:59 p.m. MT on December 15, 2023 (the "AB Contest Period", together with the ON Contest Period, the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

#### 3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. To enter complete and submit the entry form located at either <a href="https://country104.com">https://country105.com</a> or <a href="https://country104.com">https://country105.com</a> or <a href="https://cisnfm.com">https://cisnfm.com</a> (each a "Contest Microsite"), collectively the "Contest Microsites"). No entries will be accepted by any other means.
- 3.2 Limit of one (1) entry per person during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.
- 3.5 Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Call (as define in Section 6.1 below). Sponsors assume no liability for entrants not making timely phone calls to the Station due to delays in the streamed signal.
- 3.6 If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined in Section 7 below) will not be liable in any way.

### 4. PRIZE.

- 4.1 There is one (1) prize (the "**Prize**") available to be won by the Prize winner ("**Winner**") consisting of a trip for two (2) to the Destination which shall include:
  - (a) Round-trip economy airfare for the Winner and their guest (the "Guest") leaving together from the same gateway, on the same itinerary, from either Calgary International Airport, Edmonton International Airport or Pearson International Airport, as determined by the Sponsors in their sole discretion, to the Destination;

- (b) Round-trip ground transportation for the Winner and Guest between the airport and Resort (as defined below) at the Destination;
- (c) Seven (7) nights hotel accommodation in a junior suite at the Grand Sunset Princess All Suite Resort and Spa or other such venue to be selected by the Sponsors in their sole discretion (the "**Resort**") for the Winner and Guest based on double occupancy unless otherwise indicated:
- (d) An all-inclusive meal plan for Winner and Guest at the Resort; and
- (e) Two (2) tickets to the *Boots on the Beach* festival.
- 4.2 The Prize has an approximate value of five thousand Canadian dollars (CDN \$5,000.00). Actual value of Prize will depend on departure city.
- 4.3 Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.4 Prize will be distributed within one (1) day after Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

## 5. PRIZE CONDITIONS.

5.1 All bookings and/or reservations are subject to availability at time of booking. Winner must complete their booking no later than 12:00 p.m. ET on December 22, 2023. Winner and their Guest must be available to participate in the Prize as outlined in the chart below. Should Winner and/or Guest be unable to participate on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner.

- 5.2 Winner and Guest will be responsible for any other expense not explicitly included in the Prize including but not limited to transportation to and from originating airport, travel and medical insurance, travel documentation, airport improvement fees, bag check fees, taxes, gratuities, telephone calls, excursions and in-room charges. Winner may be required to present a valid major credit card upon check-in at the Resort to cover any expenses over and above the standard room charge.
- 5.3 In the event that the festival is cancelled for any reason whatsoever, that portion of the Prize shall be deemed fulfilled and will not be substituted, except in the sole discretion of the Sponsors.
- 5.4 Guest must: (i) be of the age of majority or older in their province or territory of residence; (ii) be legally able to travel to the Destination and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and (iii) comply with the Contest Rules and sign and return the Release (described in Section 7 below).

- 5.5 Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of the Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- 5.6 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

#### 6. SELECTION.

- 6.1 **Qualifier Selection.** A maximum of one hundred twenty (120) Qualifiers (as defined below) shall be selected as follows:
  - (a) On each weekday during the Contest Period at 8:00 a.m., 10:00 a.m., 2:00 p.m. and 4:00 p.m. on each Station, two (2) entrants will be selected by a random draw from all eligible entries received from the applicable Contest Microsite and their names will be announced on air (the "Cue to Call").
  - (b) Upon hearing the Cue to Call, the selected entrants must call the applicable Station's phone number (each a "Contest Line").
  - (c) For each Station, the first of the two (2) selected entrants to successfully get through each Contest Line, and within ten (10) minutes of the Cue to Call, will win an entry into the Prize draw (the "Qualifier"). In the event that neither of the two (2) selected entrants calls the Contest Line within ten (10) minutes, there will be no Qualifier for that Cue to Call.
  - (d) Each Qualifier shall be eligible for only one Prize draw entry during the Contest Period. The odds of being selected as a potential Qualifier are dependent upon the number of eligible entries received by the Sponsors.
- 6.2 **Winner Selection.** One (1) Winner shall be selected as follows:
  - (a) On or about December 18, 2023 in Edmonton, Alberta, one (1) Qualifier will be selected by a random draw from all Qualifiers during the Contest Period. The odds of being selected as a potential winner are dependent upon the number of Qualifiers. Before being declared a Winner, the selected Qualifier shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release.
  - (b) THE SELECTED QUALIFIER WILL BE NOTIFIED BY TELEPHONE NO LATER THAN DECEMBER 18, 2023 AT 12:00 P.M. ET AND MUST RESPOND WITHIN ONE (1) BUSINESS DAY OF NOTIFICATION. Upon notification, the selected Qualifier must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected Qualifier does not respond accordingly, they will be disqualified and will not receive the Prize and another Qualifier may be selected in the Sponsors' sole discretion until such time as a Qualifier satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected

- Qualifier to receive notification or for the Sponsors to receive a selected Qualifier's response.
- (c) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
- 7. RELEASE. Potential Winner and Guest will be required to execute a legal agreement and release ("Release") that confirms potential Winner's and Guest's: (i) eligibility for the Contest and compliance with these Contest Rules: (ii) acceptance of the Prize as offered: (iii) release of each of the Sponsors. The executed Release must be returned within one (1) business day of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.
- 8. INDEMNIFICATION BY ENTRANT. By entering the Contest, each entrant releases, indemnifies and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.
- 9. LIMITATION OF LIABILITY. The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest and/or the Contest Microsites.
- 10. CONDUCT. By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at the Contest Microsites throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any

entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest and/or the Contest Microsites or any related promotional website; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE THE CONTEST MICROSITES OR ANY RELATED WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSORS RESERVE THE RIGHT TO SEEK REMEDIES AND DAMAGES TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING BUT NOT LIMITED TO CRIMINAL PROSECUTION. Winner and Guest must at all times behave appropriately when taking part in the Prize and comply with the Contest Rules and any other rules or regulations in force at any other Prize-related locations. The Sponsors reserve the right to remove from any other Prize-related locations, any Winner and/or Guest who breaks such rules and/or fails to behave appropriately and to disqualify such Winner and/or Guest. Any disqualified Winner and/or Guest will forfeit any un-awarded elements of the Prize.

- 11.2 Each Winner further consents that: (a) any personal information they have provided in connection with this Contest may be shared with Direct Travel and/or Washboard Union for the purpose of facilitating the delivery or fulfillment of a Prize; and (b) Corus may broadcast, publish, disseminate and otherwise use a Winner's name, city/town/village and province/territory of residence, image and/or voice in connection with any promotion and/or publicity purposes without further compensation to Winner.
- 11.3 No communication unrelated to the Contest, commercial or otherwise, will be sent to the entrant unless the entrant otherwise expressly agrees to receive further communications from Sponsors.
